Background

The COVID-19 pandemic and the hastening of the 4IR dramatically altered the way we work, the way we communicate, and the way we live. As global economies gradually show signs of recovery, the world of work continues to undergo significant shifts forcing workers and enterprises to adapt, and adapt fast. New game means new rules, which calls for new tactics. With its straddling role both in education and labor and its potential for agility, TVET must also undertake new strategies and re-calibrate its policies to scale up and push forward the sector and provide skills to its clientele to aid the Philippines bounce back to economic recovery.

Picking up from the insights and recommendations from the TVET Policy eFora Series in 2020, the Technical Education and Skills Development Authority (TESDA) is conducting another installment for this year with the theme *Disruptions to Direction: Adaptive Strategies in TVET for Resilience towards the Future.* The Forum seeks to present TVET's new and enhanced strategies for the workers and enterprises to adapt to the new normal and be future-ready. Following the new framework the agency shall be adapting for the 5th Cycle of the NTESDP -- new mindset, restyle, reskill, and digital capacity -- the presentations shall feature industry strategies futures thinking in TVET, the national skills map, greening TVET in the context of the new normal, updates on the TESDA Online Program, and the ceremonial launch of the Skills Needs Anticipation Manual. Reactants from industry, academe, or international bodies shall also be invited to present their opinions and insights on TVET's enhanced strategies. An open forum shall follow to discuss other possible interventions in planning the to allow the audience
